
General Information :


TERMS & CONDITIONS

1. The sealed bid shall be received by this office up to **05:30 PM on 4th Aug, 2022**. Any bid received after the prescribed deadline shall not be considered. Tender should be addressed and submitted to

2. The bids shall remain valid for a period of 2 months from the date of receipt of the bid.
3. **BID PRICE :** The rates quoted by the bidders for purchase of old condemned vehicle will be on “As is where is basis”. Any statutory or other charges shall be borne by the bidder. GST will be levied extra as applicable . Rate should be quoted in the format as given in Annexure-B.
4. **Possession of vehicle :** The successful bidder will take possession of the vehicles by 3 days on receipt of 100% payment and will arrange for transportation of the same on that day at his expense. If not taken possession by 3 days this office will not have any responsibility either for safe custody or for any loss or damage to the subject vehicle after 3 days.
5. **The vehicles will be disposed off on the basis of highest quoted rate (H1). However, this officer reserves the right to withdraw the vehicles from the bidding process in case the quoted price received is less than the reserved price.**
6. If the H1 bidder will not be able to take possession of the vehicle following due procedure within the prescribed time limit as mentioned above, the committee will approach to H2 bidder at H1 rate. Necessary process will be initiated if H2 bidder agree to possess the vehicle at H1 rate.
7. **Payment :** On receipt of Sale Release Order, the successful bidder must submit the requisite sum / bid value by 7 working days in the form of Demand Draft (in favour of SAMEER Kolkata Centre payable at Kolkata) failing which the offer will be cancelled and EMD will be forfeited without giving any intimation.
8. In case the bidder is a company, the name of the company should be indicated as the bidder. In such cases the person appearing for the company should have the authorization letter in a proper format issued from a competent authority of the company. Request to change the name of the bidder in the tender after submission of the tender will not be entertained.
9. The bidders should quote the amount for purchase of the subject vehicle both in words and in figures, if there is any difference between the amount mentioned in figures and that of in words, the rate quoted in words will be taken into account and accepted on record.
10. The bidder is required to reveal his full name/name of the authorized signatory of the firm/name of father, full postal address, telephone number & mobile number and GSTIN number, if any.
11. The person authorized by bidder will be allowed to take the delivery. The bidder is required to produce any of the documents as documentary evidence for proof of their address (Ration Card Voters Identity Card / Electric Bill in case of individual and Registration Certificate in case of firms etc.).

12. The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously. This office will not be responsible for any lapse on his part in this regard.

13. Disputes, if any, shall be subject to jurisdiction in Kolkata only.
